Below is a brief report of activities of the Musculoskeletal Epidemiology Research Group over the past year:

Academic:

- PD Dr. Cesar Hincapié received a status faculty appointment as Assistant Professor of Epidemiology at the University of Toronto Dalla Lana School of Public Health, 15 Oct 2024
- Hosted the 19th International Forum for Back and Neck Pain Research in Primary Care ([IBNP Forum 2025](#)) — a premier scientific event of clinical and public health research worldwide. Extraordinary success and excellent outreach event—250 participants from 25 countries; 42 chiropractors (4 Swiss DCs) attended (24-27 Jun 2025)
- Hosted a scientific meeting of 30 leading researchers for Lancet Low Back Pain Series II Update (22-23 Jun 2025)
- Group relocation – Now 100% at UZH Epidemiology, Biostatistics and Prevention Institute as of 1 Aug 2025
- Invited to apply for the title of Adjunct Professor (*Titularprofessor*) and the right to confer a PhD (*Promotionsrecht*) at the Faculty of Medicine of UZH, 1 Aug 2025

Team: Our group currently consists of myself, **8 trainees** (2 PhD students [Javier Muñoz Laguna DC MSc, Clara Gieseke Lopes PT MSc], 1 early clinician-scientist working towards Habilitation [Léonie Hofstetter DCM], 5 students [4 chiropractic: Lea Rohner, Nathalie Schweyckart, Nathan Schmid (*Doktorarbeiten*), Matthias Schürmann (*Masterarbeit*); and 1 ETH master's thesis: Viktorija Kendjel]), and **2-4 other team members:** Michelle Suppiger (SALuBRITY trial coordinator), Nicola Schmid, Kai von Känel, Felix Tran, Ilario Barizzi (*Zivildienst*).

Publications: Between August 2024 and July 2025, we published 10 original papers (2 as first author; 6 as last author) in high-quality peer-reviewed journals.¹⁻¹⁰ We currently have 4 manuscripts in preparation and review.

Presentations: Between August 2024 and July 2025, our team delivered: 5 workshops, 3 invited presentations, 5 oral presentations, 7 poster presentations, 1 visiting professor lecture at the University of Toronto, Dalla Lana School of Public Health. Key conferences and meetings: Wennberg International Collaborative (Oslo, Sep 2024), UZH Population Research Conference (Zurich, Jan 2025), Chiropractic Academy for Research Leadership (Odense, May 2025), World Federation of Chiropractic (Copenhagen, May 2025), International Back and Neck Pain Research Forum (Davos, Jun 2025).

Funding: IBNP Forum 2025 was awarded a total of 53,000 CHF in sponsorship funding (**Hincapié as applicant**) from the Swiss National Science Foundation (20,000 CHF), Neuroscience Research Australia (13,000 CHF), ChiroSuisse (10,000 CHF), Swiss Osteopathy Science Foundation (5,000 CHF), UZH Alumni Foundation (3,000 CHF), and Physioswiss (2,000 CHF). Currently, under consideration is a project grant application (275,000 CHF) with Suva, to investigate the incidence of and causal risk factors for occupational elbow tendinopathy using Suva data.
